

GENERAL CONDITIONS

- In these conditions the following words shall have the meaning set opposite same respectively.

EXHIBIT	Any article referred to in the application by an Exhibitor as one for show by him/her at the Exhibition or permitted by the Organiser by consent in writing.
EXHIBITORS	Any person, firm or company to whom space at such Exhibition is allocated at his or her request, and includes his or their employees and agents.
SPACE	The area in Exhibition building applied for by or allocated to Exhibitor as (context requires).
STAND	The space and construction created thereon and occupied by an exhibitor.
HALL	The hall and any annex and other allocated rooms in connection therewith in which the Exhibition takes place.
AUTHORITIES	Includes anybody legally authorised to make regulations or impose conditions which regulate or affect or relate to the Exhibition.
CONTRACTORS	Any person, firm or company employed by the Owners, the Organisers or the Exhibitors for erection, fitting out to or other work on any stand in the Exhibition.
EXHIBITION	Kgotla Expo
ORGANISER	HATAB
OWNERS	Includes the person, firm or company from or under whom the Organisers have acquired the right to occupy the hall for the purpose of the exhibition.

- The Exhibitor shall occupy the space allocated to him/her and install exhibits thereon by 1600 hours on the day prior to the day of opening to the satisfaction of the Organisers. The exhibits must remain open for inspection and each stand must be adequately staffed throughout the whole period during which the Exhibition is open to visitors. No exhibits may be removed from the hall during open hours of the Exhibition. The Organisers shall be entitled to remove and store, at the Exhibitors expense, any exhibit or equipment remaining in the hall after 1800 hours on the date after closing of the Exhibition. Exhibitors are at all times responsible for the security of their own exhibits and equipment. During the installation and the demolition periods of the exhibition, no children will be allowed into the hall and at no time will animals be permitted to enter the exhibition area.
- Immediately the contract is signed, it becomes binding upon the Exhibitors who cannot in any way cancel or resile from it even though it might not yet have been accepted by the Organisers who, however, do not become bound by the contract until it has been accepted and signed by a Director or other authorised officer of the Organisers. Should an Exhibitor wish to cancel this contract for the space allocated the Organisers may, at their discretion, endeavour to sell on the behalf of the Exhibitor the space so contracted, but there being no obligation on Organisers to be successful in this sale. Should cancellation takes place the Exhibitor shall be referred to the regulations of exhibition, which stipulates that if cancellation takes place one month prior to the exhibition they forfeit 25% of the stand rental, two weeks prior 50%, one week prior 100%.
- Should any error arise in the allotment of space to any Exhibitor, no liability in regard there to including liability for consequential damages shall rest on the Organisers. In any case the Organisers will endeavour, without prejudice, to offer a substituted arrangement but they do not bind themselves to do so. The Organisers reserve the right to change the position allocated to any Exhibitor should circumstances render it necessary or desirable.
- All goods brought to the hall by an Exhibitor are at the Exhibitor's sole risk. The Organisers will not be responsible at anytime for the loss theft, fire, water act of third parties, negligence whether of Organisers, their servants or any other persons, or any other cause to any goods, property, cases, exhibits or stand of any Exhibitor or any person. Organisers will not be responsible to any Exhibitor for any act or default attributable to any other Exhibitor.
