GENERAL CONDITIONS

- 6. Each Exhibitor indemnifies and will keep indemnified to the Organisers against any liability, action, claim, demand, cost, charges or expenses arising as a result of any act, omissions, negligence or things done or omitted by such Exhibitor, his agents, servants or invites or any licenses of such Exhibitor or any other person or persons under the direction of the Exhibitor. Each Exhibitor will arrange insurance against all risks for which he is responsible under these conditions and will if so required produce to the Organisers particulars of such insurance policy and evidence of the payment of the premium.
- 7. Exhibitors agree to observe the same conditions of tenancy as are accepted by the organisers in their agreements with the owners and in particular shall refrain from doing anything contrary to any license issued by Authorities of the fire insurance policy in respect of the property upon which the Exhibition takes place, a copy of which will be made available on request. An Exhibitor shall not cut or damage the floor or any part of the walls or structure of the Hall without prior consent in writing of the Organisers. Any Exhibitor causing any damage to the Hall or any person whomsoever must pay for same and hold the Organiser indemnified against the same. (The Organisers retain a lien on all goods in respect of unpaid accounts and reserve the right to prevent removal of goods until a settlement be made and to store them at the Exhibitor's risk and charge). See clause 16.
- 8. No Exhibitor shall connect to or interfere with the electrical, gas, steam, water or other fittings in the Hall without prior consent of the Organisers and Owners and such consent will be subject in all respect to the rules and regulations of the owners and shall be done only by the Owners, Organisers or their Contractors at the expense of the Exhibitor. The Owners and the Organisers shall have the right to enter any stand to examine, test, repair or renew any electrical fittings or to remove or replace any defective apparatus.
- 9. In no circumstances shall any Exhibitor have or permit on his stand or space naked lights or oil lamps, explosives or articles of dangerous, inflammable or objectional nature nor may temporary gas or electrical fittings be used in the hall without the written permission of the Organisers and the authorised representative may remove any such articles from the building.
- 10. All stands and fittings must be substantially erected or placed and must conform to any regulations or byelaws including fire precautions and are subject to approval of the Organisers who require the Exhibitor to submit plans in advance of erection or fitting. Such safety precautions as may be required by the Authorities must be taken by the Exhibitor.
- II. Handbills and other printed matter may only be distributed from Exhibitor's own stands. Exhibitors must not paste or otherwise affix or exhibit advertisements upon any part of the building. No articles may be photographed, drawn, copied, reproduced without the consent in writing of the Organisers.
- 12. Exhibitors shall not (a) sell at the Hall stock without permission of proper Authorities (b) sell or give away permit to be sold or given away in or upon any part of the Hall any articles for human eating, drinking or smoking other than such as are supplied by the Organisers or their agents. Entertaining on stands by dispensation of spirit, wine, beers, mineral water, beverages and other refreshments either for eating or drinking must be done only in such portion of stands or offices as are not open to public view or entry.
- 13. In event of the Exhibition not taking place for any reasons, except the wilful wrongful act or omission of the Organisers, this contract shall be terminated and the Exhibitor shall be entitled to a refund of any monies paid exceeding one half of the agreed cost of space. If the venue has to be altered the exhibition held in whole or in part in another hall, postponed, restricted or if there is a failure of any of the services or facilities usually available to Exhibitors for any reason whatsoever but an Exhibition is nevertheless held, the Organisers shall not be liable for any expenditure, damage, loss or other liability including consequential damage, incurred by the Exhibitor. The varied Exhibition so held shall, for all purposes, be deemed to be the Exhibition to which this agreement relates and the Exhibitor shall be bound to make payment of the monies due under this contract.
