## **GENERAL CONDITIONS**

- 14. In the event of an Exhibitor or intending Exhibitor committing any act of insolvency, being liquidated or sequestrated (whether provisionally of finally and voluntarily or compulsorily, other than a member's windingup for purpose of amalgamation or reconstruction) or being placed under judicial management, either provisionally or finally or failing to observe and perform the obligations under this agreement or pay all monies on due date on demand this contract may be terminated by the Organisers on written notice to the Exhibitor and all monies paid by the Exhibitor under this contract shall be forfeited without prejudice to the right of the Organisers to claim for breach of contract.
- 15. No Exhibitor shall assign his rights hereunder or grant sub-licences or sub-let or divide any space allocated to him in the Hall nor shall any circulars, advertisements or photographs relating to any trader who is not an Exhibitor be exhibited on or distributed from any stand in the Hall without the consent in writing of the Organisers.
- 16. The Exhibitor undertakes to pay all monies due to the Organisers on the dates.

More specifically:-

- A. On overdue amounts the organiser shall be entitled to apply at 35% above prime and cancel any discretionary discounts which may have been indicated to the Exhibitor. For the purpose of serving of invoices and notices the Domicillium Citandi Executandi of Exhibitor shall be the address shown on this contract or that address in common usage for communication between the Exhibitor and the Organiser.
- B. Payment of any other amounts relating to services or facilities as required in terms of the Exhibitors Manual shall be paid on demand.
- C. The Organisers retain a lien on all goods in respect of unpaid accounts and reserve the right to prevent removal of goods until settlement be made and to store them at the Exhibitor's risk and charge.
- 17. The Organisers reserve the sole right of compiling and issuing any catalogue or list of Exhibits and the printing and issuing of all invitations and tickets of admission to the Exhibition and sufficient of theses will be available to the Exhibitors prior to the date of commencement of the Exhibition.
- 18. The Organisers reserve the sole right of compiling and issuing more detailed terms and conditions which may occur nearer to the time of the Exhibition. In the event of any regulations being imposed upon the Organisers by the Authorities, on receipt of notice of the same from the Organisers, all Exhibitors must immediately comply with such regulations. Should circumstances arise which are not provided for in the foregoing Rules and Regulations, all Exhibitors hereby agree to accept the decision of the Organiser which shall be made final and binding.
- 19. Any legal action in terms of this contract or arising out of it may be brought by either party in any Magistrate's Court in Botswana notwithstanding the amount in issue provided only that valid and binding unless in writing and signed by all parties that court has jurisdiction in terms of the Magistrate's Court Act or under any amendment or any substantial re-enactment thereof.
- 20. This contract, the Application Form to which it is annexed, and the Exhibitor's Manual form the whole agreement between the parties and no variations, alterations modifications or representations shall apply or be.
